Notes for Bank Staff

- The selected preset amount will be the Daily Trading Limit. The daily turnover (being the aggregate of order consideration and charges for all buy & sell orders placed via all trading channels that have been accepted by the Bank for sending or waiting to be sent to the Stock Exchange of Hong Kong on the same day) of the Securities Account will be bound by the Daily Trading Limit.
- Upon new application of Electronic Securities Trading Service, customer must be requested to furnish the Registered Information.
- Security protections are compulsory for Electronic Securities Trading Service with no opt-out allowed. Security notifications will be delivered to customer's mobile phone number, email address and in English by default or the language selected by customer (if applicable). Such information obtained via Account Mandate (for new account opening) and/or the Instruction Form for Securities Services (for subsequent application of ESTS and/or subsequent changes) will be classified as Registered Information and will be maintained in the trading system by SOD for use on such purpose. Customer should note that Short Message Service via mobile phone ("SMS") will not be forwarded even if "SMS Forwarding" service has been subscribed by customer with its telecommunication service provider (applicable to mobile phone numbers issued by telecommunication service providers in Hong Kong which starts with specified digits). The Bank cannot provide Electronic Securities Trading Service to customer who does not provide a mobile phone number and an email address. Please provide Terms & Conditions for Securities Services and Security Tips for Securities Services to customer. After successful application of Electronic Securities Trading Service, customer is required to activate the Internet Channel and register the mobile device for the Mobile Channel in order to conduct transactions via these two channels.
- 4 These instructions may require urgent attention, handling staff should call Shares Trading Centre to effect the suspension/termination immediately (if necessary).
- ⁵ Handling staff should check with SOD if there is stockholding remaining in the securities account and request customer to give disposal instruction using the Bank's specified forms (if applicable).
